**1. What are your reasons for becoming a candidate for this office?**

A full service ad agency behind me to produce compelling campaign materials, a fund raising system that will only improve with time and money, a core group of volunteers and friends who want to see this candidate succeed- and the tools to make it possible. As a small business owner- I can control my time better for campaigning than most other candidates.

**4. What do you feel will be the major issue(s) in your campaign and what is your position on it (them)?**

I will make the major issues: money in politics, CEO compensation, Turners record of graft and corruption, his voting record on the bailout- without restrictions and his lack of support for bailing out GM- which devastated this community.

**11. What involvement have you had with the Democratic Party and its candidates?**

I've worked on the Obama Campaign- and been an Elected Precinct Captain.

**12. Why is it important to you to receive the endorsement of the Montgomery County Democratic Party?**
