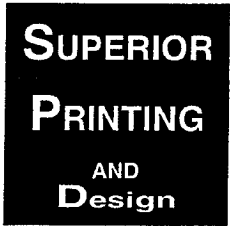





NOTICE

Procedure for Certification of Election, Governor's Commission and Oath of Office for Montgomery County Elected Officials

The following outlines the steps necessary to complete the certification process for the following elected officials: State Officers; Countywide Officers; Judges for the Court of Appeals; Common Pleas Court Judges, General Division; Judge for the Probate Division; Judges for Domestic Relations Court; all other Judges of courts of record. (Section 107.05, Revised Code)

- A Commission from the Governor is obtained by delivering to the Montgomery County Board of Elections the fee prescribed in Section 107.06 of the Revised Code.
- That fee is \$5.00 for all elected officials with the exception of County Court Judges for whom the fee is \$2.00.
- The check is payable to the Ohio Secretary of State.
- The election results will be certified by the Board of Election approximately 21 days after the election and will generate a Certificate of Election.
- The Board of Elections will forward the Certificate of Election and the fee to the Secretary of State.
- The Secretary of State's Election Division anticipates a 3 to 4 day turn around on processing the Certificate of Election and issuing a Governor's Commission.
- The Commission signed by the Governor will be mailed to the Montgomery County Clerk of Court for all judges and county officers.
- Governor's Commissions and Certificates of Election for Municipal Judges will be mailed to the Municipal Clerk of Court for the jurisdiction in which the Judge presides.
- The Clerk of Court receiving the Governor's Commission and Certificate of Election shall deliver those documents to the appropriate elected official(s).
- Members of the General Assembly do not receive commissions but need to present the Certificate of Election to their respective houses on the day they organize.
- Judges for the Court of Appeals and for the Common Pleas Court must take the oath of office within 20 days after receiving their commissions. (Section 2701.06, Revised Code)
