THE GRAND JURORS of the County of Montgomery, in the name, and by the authority of the State of Ohio, upon their oaths do find and present that: JODI HOCKETT, BETWEEN THE DATES OF MAY 1, 2023 THROUGH JULY 26, 2024 in the County of Montgomery, aforesaid, and State of Ohio, being a public official or party official, did commit a theft offense, as defined in Division (K) of Section 2913.01 of the Revised Code, when the property or service involved was owned by this state, any other state, the United States, a county, a municipal corporation, a township, or any political subdivision, department, or agency of any of them, or was owned by a political party, or was part of a political campaign fund, the value of the property or services stolen being One Hundred Fifty Thousand Dollars (\$150,000) or more but less than Seven Hundred Fifty Thousand Dollars (\$750,000); contrary to the form of the statute (in violation of Section 2921.41(A)(2) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.

SECOND COUNT:

AND the grand jurors of this County, in the name and by the authority of the State of Ohio, upon their oaths, do find and present that: **JODI HOCKETT, BETWEEN THE DATES OF MAY 1, 2023 THROUGH JULY 26, 2024** in the County of Montgomery, aforesaid, and State of Ohio, knowing the person has no privilege to do so, and with purpose to defraud or knowing that the person is facilitating a fraud did falsify, destroy, remove, conceal, alter,

deface, or mutilate any writing, computer software, data or record, to-wit: CHECKS having been kept by or belonging to a local, state or federal governmental entity; contrary to the form of the statute (in violation of Section 2913.42(A)(1) of the Ohio Revised Code) in such case made and provided, and against the peace and dignity of the State of Ohio.
